## Surveyor's Corner



Questions: (As received on the Kachina Chapter website)

"I have an acre and a guarter of land outside of Holbrook AZ, in Navajo County.

Is there any member within your organization that will survey this land, and if so, how much? Is there any activity going on in that area? if not, can you supply details on how I can obtain this information? If you are unable to answer these questions, can you supply the name of a surveyor who can?"

An e-mail note with those questions was forwarded to me, via our Kachina Chapter of IRWA, for response to questions about land surveying.

(The original note had some more specific and personal information, which has been redacted for this article.)

The following was our response to those questions:

### FINDING A SURVEYOR IN YOUR AREA:

There is a good source for locating professional Arizona Registered Land Surveyors (AZ/RLS), and, as important, registered firms, providing land surveying services.

Please reference the website of the Arizona Board of Technical Registration (AZ/BTR) http://www. btr.state.az.us/

Once there you can scroll down the left side column until you get to "LISTINGS" Under listings you can find both individual surveyors (Professional Registrant Listings), and, also, you can find professional firms offering surveying services, (under the Firm/Branch Listings section, just below the professional registrant listings, on the scrollable left side column).

Once you click onto Professional Registrant Listings you will open a new screen "Search for Professionals" - - at the bottom of that screen you can narrow your search specifically search for "Land Surveying" - - You can further narrow your search by entering an Arizona zip code for your area, (in this specific case, Holbrook AZ = 86025).

A search of the FIRM/BRANCH Listing can be performed in a similar manner.

If you do not find any surveyors / surveying-firms in Holbrook, you may need to widen the search to include Winslow & Showlow as the next best options, (Zip Codes 86047, and, 85901, respectively. Zip Codes (for U.S. cities) can be found at: http://zip4.usps.com/zip4/welcome.jsp).

NOTE: It is a very good idea to verify - (using the AZ/BTR website) - that BOTH the surveying-firm, AND, the responsible individual surveyor, are BOTH registered with the AZ/BTR, (as is required by AZ Statute law, @ ARS 32-141).

### Surveyor's Corner...continued

### THE COST OF THE SURVEY:

As to the costs, please note that Surveyors' fees, like those of any professional, are dependent on the type of services requested and/or required. That in turn determines the level of effort, and the number of personnel, and types of equipment necessary.

The following is a partial list of factors that influence the cost of a boundary survey.

- Available information.
- Research (of records and physical evidence) required.
- Clarity, (or vagueness), of the existing written property boundary description.
- Amount of surrounding land to be surveyed to correctly locate the specific 1.25 acres (often times it is
  necessary to investigate an entire section (one mile square) of land to successfully determine the accurate position of the individual parcel.)
- Number of property corners and their associated monuments.
- Terrain and vegetation.
- Accessibility.
- Whether or not improvements, appurtenances, easements, etc. will need to be located and referenced in the boundary survey.
- Whether or not a boundary dispute is known or discovered.
- The Surveyor's familiarity with the immediate area where the property is located.

The variables, as noted, can make it difficult to determine exact fee costs, but based on general experiences in the area of the survey, and the type of work requested / required, most surveyors should be able to furnish adequate estimates of costs. Note that surveyors more familiar with an area to be surveyed usually have the advantage of experiential knowledge over surveyors who are less familiar with the area.
