Land Surveyors' Influence on American History

Recently Atlantic Monthly released its annual list of the 100 Most Influential Figures in American History and six of the people on the list were famous land surveyors. Can you name them? First, the obvious, Abraham Lincoln, George Washington and Thomas Jefferson come in at 1, 2, and 3 respectively. Henry David Thoreau is #65 and Meriwether Lewis and William Clark share #70. All of these influential Americans were land surveyors at one point in their life and most for their entire lives.

Abraham Lincoln saved the Union and was an excellent leader during the most trying time our country has ever seen. There is no doubt that his years plunged into books on surveying and mathematics and studying all day, and sometimes all night helped him to become the great leader and thinker that he was. Lincoln laid out roads and towns in the mid-west as the new nation expanded westward. For sure the patience he learned surveying prepared him for his political life.

George Washington could never tell a lie and perhaps this is why he was such a great surveyor and founding father. At the age of 17 he was appointed as Virginia's Surveyor General by the College of William and Mary. The college had been charged with the examination and licensing of surveyors. Washington's frontier surveying experience served him well in the mobilization of the British army defending the northwestern boundary of Virginia in 1754, as few men had as thorough knowledge of northwestern Virginia. Between 1747 and 1799 Washington surveyed over two hundred tracts of land and held title to more than sixty five thousand acres in thirty-seven different locations. Deeply concerned about the lack of accurate maps available to his army during the Revolutionary War, Washington created the office of Geographer to the Continental Army. George Washington was not only a remarkable man, but also a very fine surveyor.

Another famous Surveyor General for Virginia, Thomas Jefferson was also appointed as County Surveyor for Albemarle County, Virginia on October 14, 1773. During his tenure as Secretary of State (under President Washington) and as President, Jefferson's instructions and appointments of surveyors to official posts gave the young nation the foresight and direction necessary to promote the orderly settlement of the frontier.

Henry David Thoreau was born in Concord, Massachusetts, on July 12, 1817 and spent much of his youth outdoors, enjoying nature and honing his natural ability of observation. While living at Walden Pond he built a small, comfortable one-room house where he could live simply and near to nature, and devote his time to studying, gardening, and writing. While there, he made the first accurate map of Walden Pond and rekindled his interest in surveying. Although he lived a solitary existence, he regularly entertained guests and began to work in and around Concord as a surveyor. He also described surveying as, "a noble employment which brings you within hearing of [the birds]". Perhaps two of the most famous

surveying in American history did something few surveyors ever have done; they mapped and recorded a new land never before described or monumental.

America's size was doubled when Jefferson purchased the Louisiana Purchase from Napoleon, yet he did not know exactly what he had bought. The "Corps of Discovery" led by Lewis and Clark shoved off on May 14, 1804 from wood River, Illinois to map and record the new land, after taking a reading of 38 deg. 55 min. 19.6 sec. North latitude. The 45-person party traveled primarily by keelboat and canoe and made about 10 to 20 miles per day.

On July 31, 1804 they took a meridian altitude and calculated the latitude of their position to be 41 de. 18 min. 1.5 sec. North. Latitude was much easier for them to measure than Longitude as they had no accurate timepiece for determining Longitude. However, they were able to estimate the distance traveled each day with considerable accuracy, and, combined with compass and latitude, they were able to record quite good positional information. These early surveyors forged the trail to the west for millions of settlers that soon followed. Being a surveyor will most likely not land you on the 100 most influential figures in American history list. But this noble profession has been the springboard for many great Americans. Perhaps that is why Ellen Henrietta Swallow Richard said, while attending Vassar College where she took a course in land surveying. "I prefer surveying for a week to spending a week in fashionable society even of the best class."


