### CHANGES IN LOAN AND CLOSING DOCUMENTS

the past, owner occupant borrowers/buyers would be given estimated costs by their lenders, but they were truly estimates. At close of escrow the borrower might be informed that loan costs and annual percentage rate (actual interest expense) had risen substantially. With closing of the transaction or refinance of utmost important to the borrower, most closings went ahead with the increased costs being shouldered by the borrowers. These actions were abuses of the lending process and federal legislation was passed which was designed to protect borrowers. Effective January 1, 2010 new procedures will be implemented.

Here is how the new process works. Three days after loan application information is provided to the loan originator, a Good Faith Estimate (GFE) and a Truth-in-Lending (TIL) statement must be sent to the borrower. Generally, the GFE states the costs and general terms of the loan to be provided while the TIL informs the borrower of the annual percentage rate (APR) of the loan. The borrower must wait seven days from the date the GFE and TIL are sent before closing. This period is to ensure that the borrower has ample time to compare the terms provided on the GFE and TIL with offers from other lenders. The offer from the lender to the borrower must remain on the table for ten days from the mailing of the GFE and TIL. After the ten day period, the lender may withdraw the terms presented on the two documents.

If the annual percentage rate changes more than 1/8<sup>th</sup> of one percent, the lender must send a new TIL to the borrower three days or more before consummation (signing) of the loan.

At close of escrow the estimated costs on the GFE are compared to the actual costs on the HUD – 1 (the final statement to the borrower of all costs of the transaction). Costs are broken into three categories, one that tolerates no change, one that allows change up to 10%, and one that allows unlimited change. Any increase in costs that exceeds allowable limits must be refunded to the borrower by the lender, either at close of escrow or within thirty days after close of escrow.

This is the most profound change to the closing process in over 30 years. While the early stages of the implementation will be difficult, it will afford much needed benefits and protections to borrower.

The procedures outlined above are for the protection of borrowers/buyers of owner occupant properties. They do not apply to sellers of any types of property or to commercial buyers and sellers.



# "Is Your Chapter Protected"?

Background: Today's headlines routinely read: "Girl Scout Troop Leader is arrested for Embezzling Troop Funds" "Police: Embezzled Money Used for basketball. "State's Former Veteran's Department Chief Indicted"

Embezzlement and misappropriation of funds, cover-up, and inappropriate hiring practices are common throughout profit and non-profit organizations. These are some growth areas of fraud that are draining the resources of today's organizations. The main cause is misplaced trust. Trust is a strong bind within organizations and is often misused. This paper presents current situations and their relevance to International Right of Way (hereinafter IRWA) Chapters, with respect to proper safeguarding of assets.

According to Jan Miller in "Non-Profit Fraud", Non-profits had the second highest median loss (\$100,000 per fraud occurrence) of the organizations studied. The culture of a non-profit is one of utmost trust, and the general perception is one that all members, officers, and workers are ethical and trustworthy. It is this type of environment that fosters dishonesty resulting from inadequate internal controls and separation of duties. Stephanie Strom highlights this phenomenon in "Report Sketches Crime Costing Billions: Theft from Charities" with a case involving a volunteer treasurer of the Madison County Humane Society in Indiana. The treasurer was charged this month with using \$65,000 of the charity's money to buy jewelry and makeup. Furthermore, the report found that the typical theft from a charity was committed by a female employee with no criminal record, who earned less than \$50,000 per year, and worked at the non-profit at least three years. The amount stolen was less than \$40,000. Lastly, the most grievous cases involved male executives earning \$100,000 to \$149,000 per year who had been typically employed longer. 2006 statistics highlight that almost \$40 billion or roughly 13% of the total \$300 billion given annually to charities was embezzled.

IRWA chapter case scenario: The above cases and statistics are alarming and present a challenge for all IRWA Chapters. The following questions need to be asked: Whom can you trust? Are your Chapter's accounting procedures and internal controls in order? Any signs of trouble?

After thinking about the above questions, please consider a formal review of the following potential areas of concern related to Chapter functions: \* Background check of officers, committee members, and contracted vendors. \* Separation of duties. \* One bank account. \* Signature cards and signing authority. \* Bonding of officers and committee members. \* Website and domain name security measures. \* QuickBooks or other recognized accounting program. \* Security measures in place if using payment services such as Pay Pal Records retention and safeguarding. \* New officers succession plan. \* Established By-laws and procedures \* Annual audit plan and review

The above considerations are basic items, that if put in place according to internal auditors and forensic accountants, can go far in preventing fraud and problems. A lack of proper internal controls and separation of duties can result in disaster for IRWA Chapters. The following IRWA Chapter case scenario illustrates unintended consequences of trust. The Chapter in question had a former troubled officer, who had performed duties flawlessly until unfortunate personal problems occurred. This officer maintained the website, newsletter, Pay Pal account, tax preparation, and annual seminar duties. Basically, unconditional trust was placed in this former Chapter officer, and no back-up was provided or separation of duties existed. The other Chapter officers blindly relied on this person to conscientiously perform their duty as a trusted officer.

As the adage goes, 'There is something rotten in Denmark' and indeed there was in the Chapter's case. The problems of this system became apparent with noticeable changes in the commitment, personality, and behavior of the former chapter officer. This officer at times became belligerent, hostile, and demonstrated a disrespectful attitude to other chapter officers and members when questioned. According to forensic accountants, this is the tell-tale sign of trouble, and indeed things were about to unravel.

Problems surfaced when the Educational Chair reviewed revenue and expenses over a period of several years and noticed inconsistencies. These inconsistencies and patterns revealed systematic deposits and withdrawals to an unauthorized account. The frequency was consistent with a pattern of education classes, year-end, and appointment of new officers. Subsequently, a formal review of all accounts, passwords, do main name, and records was performed. An outside team including a CPA, attorney, and website consultant, as well as Chapter officers were able to re-construct the fraudulent scheme. After exhaustive research, it was determined that a significant amount of the Chapter funds had been embezzled.

**Outcome:** Hard work and determination eventually resulted in a favorable ending to this unfortunate situation. The Chapter has initiated the following: \* Separation of duties, including website and newsletter editors.

- \* Checks and balances for checking accounts and signing authority. \* One checking account with signature cards. \* Chapter has own domain name. \* Electronic credit card processing of payments through IRWA Headquarters. \* Annual audit by CPA. \* Utilization of QuickBooks with monthly and annual reconciliation.
- \* Active role of all officers. \* Updated by-laws and procedures.

The chapter has recovered the embezzled funds, along with all associated fees. Furthermore, the former troubled Chapter officer has been prosecuted criminally.

Conclusion: The most important concept to consider is to formulate and implement a system of internal controls with many checks and balances. One must review the organizational structure and duties to avoid carte blanche trust in any one officer or member because it takes a team of Chapter officers to get the job done. Former President Ronald Reagan said, "Trust but verify"! Lastly, please ask yourself, "Is Your Chapter Protected"? (Mark A.
